After reviewing [REDACTED] file (file# [REDACTED] and SS# [REDACTED]), and based upon our discussion at the case conference, I have decided that TPU will not proceed with formal disciplinary charges against [REDACTED] at this time. Please note, the decision not to accept the case at this time, does not preclude you from requesting a second TAC in the future once you have implemented the recommendations that we discussed at the TAC.

[REDACTED] was reassigned on October 1, 2007 based on your finding that [REDACTED] was incompetent. Based on TPU's decision not to accept the case, [REDACTED] who is currently assigned to an ATR must return to teaching. You must decide based on the below-listed *three* options your preference for [REDACTED].

- 1) [REDACTED] returns to your school immediately as a teacher, and the substitute is released. If there is currently no vacancy in his license area, [REDACTED] will remain in the ATR until a position materializes. If no position materializes between now and September 2008, [REDACTED] will, nevertheless return to your school in September 2008; **OR**
- 2) [REDACTED] will be assigned to another school day to day, with the understanding that he will return to your school in September 2008; **OR**
- 3) [REDACTED] continues in the ATR with a stipulation that he will seek a transfer to another school. If [REDACTED] is not successful in seeking a transfer, he will be returned to your school in September 2008.
